



## 2024 – 2025 Southwest Hockey Association Volunteer Bond Agreement

**The strength and success of Southwest Hockey depends on its volunteers!!**

### I/We understand, and acknowledge that:

1. I/We am/are required to fulfill the family Volunteer Bond (VB) as mandated by Southwest Hockey Association (SWH) for the current season and it is **MY/OUR responsibility to sign up, work AND report credits accordingly, and PRIOR to the deadline.**
  - a. **NOTE:** Where there may be a “split-family”; any Parent / Guardian who completes, and acknowledges the Volunteer Bond Agreement Form, is recognizing that this program is a requirement of registration. Meaning that regardless of who signs the VB Agreement at the time of registration; is acknowledging the VB obligation in order to avoid any penalties, and for the members’ account to remain in good standing.
2. The VB value is \$500 for Community, and \$350 for House League.
3. The Community Program requires four (4) credits, and the House League Program requires two (2) credits in order to fulfill the commitment of the VB.
  - a. If I/We complete two (2) credits during the new Bonus Opportunity Phase (*dates noted on website*), then our VB will be considered complete for the season.
4. Should I/We fail to report completed credits by the deadline, **OR** fail to obtain the minimum credits required (Community Program – 4 Credits, House League – 2 Credits **OR** Bonus Opportunity – 2 Credits); our family member account will be invoiced accordingly; by the conclusion of the season, and our family will be financially responsible for the Volunteer Bond.
5. Should the VB not be completed either in service, or dollars; by March 31<sup>st</sup>, I/We recognize that:
  - a. A \$50 Late Fee will be applied, in addition to the applicable VB value noted above;
  - b. Our family will be placed as a ‘Member Not in Good Standing’ until the VB has been satisfied by the Association;
  - c. Player Movement will NOT be considered while the VB amount remains owing;
6. I/We ALSO have an obligation to our team(s) to support & ensure sufficient volunteer coverage throughout the season, **regardless of the status of our Association Volunteer Bond (VB).**
7. Families cannot ‘Opt-Out’ of the VB until after January 15<sup>th</sup>. There are many opportunities available for varying skill sets, and Southwest Hockey is hopeful that members will give their time.
