

2024 – 2025 Cash Raffle Rules

- 1. All raffle tickets must be sold in the province of Alberta.
- 2. A total of 20,000 tickets are printed and available for sale at \$10.00 each.
- 3. There is no limit to the number of raffle tickets that one person can purchase.
- 4. Raffle tickets shall not be sold to a person under the age of 18 years of age.
 - a. Ticket sellers must advise ticket buyers not to write the name of a person under the age of 18 years of age on the ticket. If the name on the winning ticket proves to be a person under the age of 18 years of age, the prize will be awarded as per The Trustee Act.

- 5. Purchasers of raffle ticket(s) must have their name, address and phone number legibly printed on each ticket.
- 6. In the event a winning ticket stub has more than one name on it, the first name listed shall be considered the Entrant and Southwest Hockey Association (SWHA) shall award the prize to that person. If that name is illegibly printed, then the second name will be awarded the prize. SWHA and the Alberta Gaming & Liquor Commission (AGLC) are not responsible for any disputes which may arise between the different individuals whose names appear on the ticket stub.
- 7. Entrants shall retain their ticket stub. In the event any dispute or controversy arises concerning the winner of the draw, the entrant may be required to produce their raffle ticket stub.
- 8. There are no restrictions on SWHA Board members, general members or their families with regard to purchasing tickets.
- 9. If 3600 tickets are not sold by December 20, 2024, SWHA will request draw date extensions with AGLC.
- 10. All tickets MUST be received by SWHA prior to 8:00pm January 20, 2025 to be eligible for the draws.
- 11. The official prizes are as follows.
 - a. 10 individual prizes of \$2,500 cash
 - b. 1 prize of \$5,000 cash
 - c. 1 prize of \$10,000 cash
 - 12. All Draws will take place in the Southwest Hockey Office. Located in Arena #1 (Cardel Rec South) 333 Shawville Blvd. SE, Calgary, Alberta T2Y 4H3 On January 25th 2025. The draw is open to the general public.

The scheduled draw announcement dates and corresponding prize amounts will be as follows:

- 13. The draw will be videotaped as one (1) ticket is drawn from a transparent or mesh constructed draw barrel of which tickets can be seen from the outside.
- 14. The winning ticket will be drawn manually by an individual who does not hold a ticket in the draw, in a random manner.
 - a. Only the person making the draw will put their arm into the draw barrel.
 - b. They will have no clothing on their arm below their elbow.
 - c. They will exhibit their draw arm and both sides of their open hand to the draw witnesses immediately prior to making the draw.
 - d. When selecting the winning tickets, the person making the draw shall look away from the draw barrel and in the direction of the witnesses.
 - e. Winning tickets will be placed back in the raffle barrel and will be rotated 1 time between identical prizes and 3 times between non-identical prizes. One witness that does not hold a ticket in the draw, will be in attendance.
- 15. At least two executive members of the licensed charitable organization (or delegates) and one witness that does not hold a ticket in the draw must be present to witness each draw. Contact information (name and phone number) of both draw witnesses must be documented and maintained in the raffle records.
- 16. Winning tickets will be recorded and then immediately returned to the draw barrel to be eligible for remaining prize draws.
- 17. The winners do not have to be present to win the prize.



- 18. The winners have up to three (3) months from the Draw announcement Date to claim their prizes. The winners must present valid identification to SWHA to claim their prize.
- 19. If a winner cannot be located within three (3) months from the draw announcement date SWHA will donate the prize back to itself, or to another charitable Association, based on the approval of the AGLC.
- 20. Tickets will be sold via direct sales.
- 21. Tickets will be sold for cash only.
- 22. No refunds will be offered once a ticket has been purchased.
- 23. The winner will be notified by phone on the corresponding draw announcement date, once notified the winner will be announced on SWHA's Social Media platforms (Facebook, Twitter and Instagram) as well as our website <u>www.southwesthockey.ca</u>.
- 24. In the event that SWHA becomes aware of tickets being stolen or misplaced, SWHA shall notify AGLC immediately and file a Discrepancy Report within three (3) days.
 - a. If the ticket(s) were lost or stolen **before they were sold**, SWHA shall advertise in the market area where the tickets were lost or stolen and that these tickets will not form part of the draw and will not be eligible for prizes. At the location of the draw(s) prior to the draw, SWHA will announce the lost or stolen tickets and that they will not form part of the draw.
 - b. If the ticket(s) were lost or stolen <u>after they were sold</u>, SWHA shall advertise in the market area that tickets with the affected serial numbers were lost or stolen and will not form part of the draw, and anyone holding such a ticket should contact SWHA so that, if required, another ticket can be issued.
- 25. Any suspected cheating or other irregularities shall be reported immediately to the AGLC at: 1-800-742-7818 (24 hours).
- 26. General: By accepting the prize, winners agree to hold Sponsors, its Agencies, Affiliates, Subsidiaries, Agents, Advertising and Promotion Agencies, and anyone else involved in the development, production or handling of the raffle and their respective Directors, Officers, Employees, Volunteers and assigns, harmless against any and all claims and liability arising out of use of prize. Decisions are final on all matters relating to this raffle. By participating in the raffle, entrants agree to be bound by the Official Raffle Rules and the decisions of SWHA.
